REQUEST: For PCC approval following agreement at the funding meeting on 18 November 2015.

Title: ABC Counselling, Play Therapy & Family Solutions C.I.C - Transition Clubs

Executive Summary:

ABC is leasing a local community centre to deliver two weekly Transition Clubs from September 2015. The aim of the Transition Clubs is to support vulnerable Year 6 and 7 children to make a successful transition from Billingham South Community Primary School to Northfield School and Sports College in Billingham.

ABC plans to deliver a twelve month group work programme for 24 children on Thursday and Friday evenings. Two experienced and professionally qualified sessional workers and four trained volunteers will facilitate 92 weekly group work sessions.

The funding the PCC has provided will pay for equipment and materials and a proportion of the rent costs for the building the club uses.

This initiative supports working for (i) Diverting people from Offending, with a focus on rehabilitation; and (ii) better industrial and community relations which is one of the PCCs priorities.

Decision:

To approve £5,200 spend from the PCC Community Safety Initiative Fund to ABC Counselling, Play Therapy & Family Solutions C.I.C for purchasing equipment and rent costs for a twelve month group work programme supporting 24 children.


