The Community Welfare Trust and Friends of Ropner Park with the support of Stockton Borough Council will provide an Eid Festival in Ropner Park in Stockton on Sunday 26th July 2015 to celebrate the end of Ramadan. The aim is to bring together an anticipated 2,000 people from the local communities of Parkfield and Oxbridge to celebrate this festival with food, entertainment and most of all a mutual understanding of each others customs and traditions.</p> <p>This event will include entertainment for families and people of all ages, fairground rides, other attractions and food. There will be two marquees: one for the food and one for visiting crafts people to display their wares.</p>


