Executive Summary:

The charity Kidz Konnekt have bid for for funding to undertake community engagement sessions, provide services and support for young people under 25 in Redcar & Cleveland. This will be provided through a series of events and workshops. Their vision is of a society in which children and young people contribute to their full potential, are valued, and their rights respected. Workshops and events are focussed on improving children and young people's experiences and life chances, reducing the impact of inequalities and increase resilience.

Kidz Konnekt focusses on those areas of most deprivation and currently provide targeted youth support through a range of activities and work in partnership with schools, other voluntary organisations and the statutory youth services.

Decision:

To approve funding of £35,700 to support the delivery of a programme of activities and services targeted at young people under the age of 25 in the Redcar & Cleveland area. Further details are summarised as follows, further details are available in the grant agreement.

- youth clubs per week during term time 39 weeks of the year.
- positive activities per week school holidays 13 weeks of the year.
- 3 month long targeted motorised safety project
- 3 month long out-door education/activity project
- Talent Show
- risk taking behaviour education workshops per year
- Street work and targeted activity over Bonfire and Halloween nights
- Large community summer event
- Young Leaders volunteering in the community once a month.


