<b>Title:</b> Funding - Summer Fun Club - Positive Parents Group			
<p><b>Executive Summary:</b> Positive Parents are a voluntary group made up of local parents within Hartlepool that aim to engage with young people, parents and the wider community in Hartlepool. The Group recognised there was a need for young people to access activities at a reduced rate.</p> <p>They have applied for funding for a contribution towards their Summer Fun Club. Their programme offers a diverse range of activities and family events over a four week period during the summer holidays to help divert youngsters away from antisocial behaviour. Last year, over 220 young people registered for the four week initiative with a footfall of over 2000 visitors.</p> <p>The group has been successful in receiving £2,680 from other organisations in support of their programme and requires a further £1288.20 for providing activities.</p> <p>This Summer Fun Club supports the PCC's objective of Securing the Future of Our Communities.</p>
