<b>Title:</b> Funding - CCTV - RDA Unicorn Centre			
<p><b>Executive Summary:</b> The RDA Unicorn Centre is a purpose built riding for the disabled facility which offers riding therapy and learning and training opportunities for over 200 disabled adults and children from the Tees Valley area each week. Opened in 1998 the Centre has become an established part of the local community, with a strong contingent of about 100 local volunteers assisting with riding lessons each week.</p> <p>In the last year the Unicorn Centre have suffered numerous incidents from horses being attacked and chased, intruders carrying knives and firearms to drug taking. Volunteers at the Centre as well as disabled participants have also been threatened which has caused great distress and concern for their personal safety. The Centre have kept a log of all of the incidents that have occurred there and this was passed onto the PCC.</p> <p>The Centre have requested £5,069.86 funding from the PCC to upgrade the current CCTV system and add additional cameras. The Centre have also been fortunate to receive £10,000 from a national Foundation for the CCTV.</p>			
<b>Decision:</b> To approve £5,069.86 spend from the Community Safety Initiative Fund for RDA Unicorn Centre to purchase an upgraded CCTV system.




