

**THE POLICE & CRIME COMMISSIONER FOR CLEVELAND****DECISION RECORD FORM**

REQUEST: For PCC approval.
Title: Mutual Aid 2017/18
Executive Summary: Cleveland Police has supported a number of Mutual Aid deployments between Apr 2017 - July 2017 which were not part of the budget set at the start of the year. In line with national guidelines the provision of Mutual Aid is charged to the Force to whom the Mutual Aid is being provided. Cleveland Police has incurred expenditure that was not provided for when setting the 2017/18 budget in providing Mutual Aid, of £45,236.16. The total amount to be reimbursed to Cleveland for providing these services is £55,722.62, which takes into account the full costs, in line with national charging agreements, of the services provided. The Mutual Aid deployments have been as follows: <ul style="list-style-type: none">• Sporting Event - Grimsby v Doncaster - Humberside Police (£4,937.57)• Sporting Event - Scunthorpe v Millwall - Humberside Police (£19,237.02)• Operational Support - Operation Newtown/Parklife - Greater Manchester Police (£9,253.29)• Protest/March - Operation Boxford - Greater Manchester Police (£4,627.35)• Operational Support - Operation Custodian - Greater Manchester Police (£6,391.59)• Sporting Event - Sheffield Wednesday v Glasgow Rangers - South Yorkshire Police (£11,275.80) Cleveland Police are therefore requesting the release of £45,250, from the income to be received by the PCC, to pay for the additional costs that they have incurred in providing this Mutual Aid. This will result in an increase in the budget available to the Chief Constable of £45,250 which will in turn ensure that the provision of Mutual Aid has not reduced the funding available to the Chief Constable for Policing within Cleveland. The 'over-recovery' of income of £10,472.62 will lead to an underspend during 2017/18 and will be made available to support future financial plans. This supports the PCC's priority of Investing in our Policing.
Decision: The PCC is asked to increase the budget of Cleveland Police by £45,250 from the income received/receivable from the provision of mutual aid to other Force areas. This will ensure that the funding available to the Chief Constable for Policing in Cleveland has not reduced as a result of the provision of Mutual Aid to other areas of the country.


