<b>Title:</b> Funding - EPIC Teesside			
<b>Executive Summary:</b> EPIC Teesside is a social inclusion project that aims to provide activities and services to vulnerable young people and families regardless of race, ethnicity, gender or sexuality.  EPIC have recently helped to re-open the community hub at Primrose Hill in Stockton after being closed for nearly ten years. During the summer EPIC ran a successful play scheme from the hub which engaged 8-12 year old young people in activities at the centre with two young people supporting delivery from another estate who were previously involved in anti-social behaviour and have now been trained as peer mentors supporting other young people. As a result of the summer programme and feedback from the community EPIC have launched a youth club for 8-14 year olds at the hub and have requested funding from the PCC to purchase arts and crafts materials and sports equipment for their youth clubs.  The youth clubs aim to provide positive social activities to divert young people from anti-social behaviour and crime.  This request supports the PCC's objectives of Working Together to Make Cleveland Safer and Securing the Future of Our Communities.			
<b>Decision:</b> To make £700 payment from the Community Safety Initiative Fund for EPIC Teesside CIC to purchase equipment for their youth clubs.
