National Police Air Services update

The National Police Air Service has provided air services for policing across England and Wales since October 2012. Further background information is available on <u>www.npas.police.uk</u>. Its 18 strong strategic board is made of 6 PCCs, 6 Chief Constables, plus representatives from the Metropolitan Police, British Transport Police and the Home Office. I joined the board at the end of 2014, representing the North East and Yorkshire area, filling a vacancy as requested, with the support of PCC colleagues.

Since 2010 policing has suffered substantial funding reductions from the government under austerity measures, which equates to over 25% out of overall budgets. HMIC recently confirmed this as total cuts of £2.5bn, with every possibility of further reductions in the future. This translates into policing cuts running into hundreds of millions of pounds across the country, impacting on services, including air support. Since 2010 Cleveland has had £37m in cuts from policing budgets; Durham £20m; and Northumbria £118m.

NPAS has operated within this context of reducing services accordingly. At the same time NPAS needs to evaluate how it has operated, what it should be providing, and how the service moves forward. NPAS has reduced costs by 23% during recent years, but now needs to find further financial savings of at least 14% over the next 3 years. This is also to be further reviewed in 12 months time. In broad terms, the budget has gone down from £54m to £44m and now will go down to £36m. Numbers of bases from 29 down to 23 and more recently down to 15. Helicopters down from 30 to 28 to 19. Fixed wing aircraft were at 3 and it is proposed to increase to 4, as they can provide some air support services at cheaper cost than helicopters.

Of the current 23 bases across the country, only 4 are operating 24/7. The future proposals are for 24/7 operation from both Newcastle and Cargate, plus a north facing 24 hour patrolling fixed wing aircraft.

The response times for Cleveland provided by NPAS senior officers are calculated at 20-22 minutes; for Durham from 16-20 minutes; and are estimated journey times from the Newcastle base. These projections are based on the calls for service and other historical information.

Moving forward, I will be taking a close interest in discussions starting in the next few weeks to develop a new financial model for NPAS and will be seeking reductions at the earliest opportunity in terms of Cleveland, and a fair funding model generally. I have already discussed with senior police colleagues in Cleveland operational aspects to the revised model and have received appropriate assurances regarding use of other police assets and resources in future in terms of the streamlined air support service.

I will be monitoring NPAS closely moving forward, including seeking further local discussions where appropriate. I hope this information is of interest and if you have any questions or comments, please get in touch.

Dear Mark,

My apologies for the short notice to cancel this morning. Due to an urgent meeting in Wales now I won't be able to make the Board meeting tomorrow. I have spoken to you and other colleagues to share my views on the papers and agenda.

I would like formally to record areas of serious concern. The Board papers are a disgrace. The minutes are confusing, poorly written and inaccurate. The papers in general are messy and inconsistent. The minutes, for example, do not reflect the tone of discussion about the continuing structural deficit, nor the conclusion, which was to demand a written explanation of why decisions were taken and by whom. They do not record any desire for remedial action which I, for one, expressed. In two years Board members have never been presented with a full set of accounts. This must be rectified before our next budget setting round.

I still find it outrageous that NPAS has spent over £900,000 this year that it was expressly not authorised to spend, which could have been put to other use. This is not a matter of "looking backwards". It is a matter of fundamental accountability. It directly affects our ability to respond to future needs. What are we doing to ensure the problem is not repeated? Is there a Corporate Governance document for NPAS? What are the delegated spending limits, and to whom? Simple control measures might reduce problems in future.

At present I find it very hard to justify to PCCs in my area the money they are already spending on NPAS, still less any increase which might be sought in future. I am not prepared to support the status quo any longer. These are issues we could, and should, resolve regardless of the Met's decision or any other work. NPAS will achieve little operational, and it certainly won't save money, without proper management processes in place.

I am sorry I am not able to make these points in person at the meeting. I hope we can see real progress on a thorough review of governance by the next meeting in the New Year.

Dear Colleagues

I write to you in my capacity as Chair of the National Police Air Service (NPAS) Strategic Board. Following the Board meeting for NPAS held on 11 December 2014, it was agreed that information and decisions regarding the NPAS budget and charges should be communicated to you all as well as Board members to assist with planning and expectations.

Firstly, I am pleased to advise you that the revenue budget for NPAS for 2014/15 will meet the planned savings targets. Unlike last year, this is without revenue support from the Home Office and has been achieved through procurement savings, one off and new income streams and increased use of capital funds. There will be a degree of underspend which is dependent on the continued programme of adoption of remaining forces into the service, but current indications are that these are due to join. The Board have agreed to use this underspend to fund the resources required to implement Phase 2 of NPAS.

In relation to the budget going forward, and so as to provide a financial context for the service to operate within, the Board also proposed that the NPAS budget should have an ambition to deliver between 5-7% savings annually covering the next CSR period. The financial year 2015/16 would be the start of that process and savings would be expected to start to be delivered in year. A further Strategic Board meeting is planned for 29 January 2015 where operational modelling work, (including received change requests for hours), will be married up with the budget aims so that the future NPAS purpose and structure and a transition plan can be decided on for Phase 2.

It is important to note that from the 2009/10 base line there has been a 23% saving in revenue costs in England and Wales amounting to £12.8m for air support. However, it is recognised that the financial pressures faced by policing mean that by necessity NPAS should look at achieving further savings through developing a new operating model.

When this new configuration is determined, the pricing model work can then be re-profiled against this new structure and budget. It is highly unlikely that a new pricing model will be agreed in time for implementation in 2015/16 and for budgeting purposes I recommend that you base your NPAS costs on the charges currently in place whilst we move towards achieving further savings. I recognise that this is not the ideal position to be in, but assure you that we are working hard to deliver a satisfactory outcome for all.

If you have any queries with regards to the content of this letter, please could you direct them to the regional representative on the NPAS Board who will provide a consolidated input to the January Board meeting for any issues and concerns that you have. Following that Board, further communication will be provided on the decisions made, plans and expected outcomes.

Dear Police and Crime Commissioner /Chief Constable

As lead Force for the National Police Air Service (NPAS), WYP was asked by the NPAS National Strategic Board which includes PCC and CC representatives from each of the six regions to consider the implications of reducing the service's revenue budget in line with the anticipated CSR budget cuts.

As result of this request, WYP has built and developed a simulation model and undertaken a detailed analysis of these cuts using the model which examines the implications of a 14%, 21% and 28% reduction in cost. The simulation model has used the previous year's demand profile to assess the implications of such cuts and how it would impact on the current service. This was achieved by amending: the number of rotary aircraft; the number of fixed wing aircraft; and the number / location of bases.

The outputs from this exercise are attached and show three scenarios which achieve the set targets. The tables and graphs show the <u>potential</u> impact of these changes on both a regional and Force level. Please note that the models are not a 100% representations of the real world but should be seen as an indicator of the potential service levels following implementation of the preferred model.

The attached three model outputs will be considered at the forthcoming National Strategic Board (29th January 2015) where your representatives will be asked to identify their preferred option i.e. NPAS to remain its current format, a 14% savings model, a 21% savings model or a 28% savings model.

Dear Mark & NPAS colleagues,

Further to discussions at the board meeting last week, I am writing to confirm my agreed request that senior officer(s) from NPAS, together with technical officer(s) who developed the model, attend a presentation to the North East. My proposal, which I've begun to discuss with NE PCCs and senior officers, is between now and next board meeting on 19th February NPAS attend a local presentation, which I'll host and chair as NE board re at Cleveland Police HQ, where NPAS can explain rationale behind model and proposals so far. This will give PCCs and senior police officers in the North East the opportunity to scrutinise the proposals in appropriate detail. This should include confirming whether Durham/Tees Valley (DTV) base is proposed to remain, giving the North East and Cumbria 2 bases out of the proposed national allocation.

My intention would be allowing an hour for presentation, questions, followed by a discussion within the North East & Cumbria re our options going forward.

You may recall I raised concerns at the board, from a North East perspective if DTV goes, in terms of the substantial distance between Newcastle and Wakefield; the significant increase in response times which we believe to be up to 1/2hr for Cleveland and Durham in particular. You will also recall I raised concerns re the inequity of the funding model from Cleveland's point of view, in that we are currently paying around £1.4m/2.8% of costs of NPAS, when we have less than 1% of the population and receive around 1.1% of the overall policing budget.

Further to discussions at the board meeting last week, I am writing to confirm my agreed request that senior officer(s) from NPAS, together with technical officer(s) who developed the model, attend a presentation to the North East. My proposal, which I've begun to discuss with NE PCCs and senior officers, is between now and next board meeting on 19th February NPAS attend a local presentation, which I'll host and chair as NE board re at Cleveland Police HQ, where NPAS can explain rationale behind model and proposals so far. This will give PCCs and senior police officers in the North East the opportunity to scrutinise the proposals in appropriate detail. This should include confirming whether Durham/Tees Valley (DTV) base is proposed to remain, giving the North East and Cumbria 2 bases out of the proposed national allocation.

My intention would be allowing an hour for presentation, questions, followed by a discussion within the North East & Cumbria re our options going forward.

You may recall I raised concerns at the board, from a North East perspective if DTV goes, in terms of the substantial distance between Newcastle and Wakefield; the significant increase in response times which we believe to be up to 1/2hr for Cleveland and Durham in particular. You will also recall I raised concerns re the inequity of the funding model from Cleveland's point of view, in that we are currently paying around £1.4m/2.8% of costs of NPAS, when we have less than 1% of the population and receive around 1.1% of the overall policing budget.

I will be sharing this note with colleagues in the North East and would be grateful if you could confirm available dates to attend within the next couple of weeks in order to finalise arrangements.

Dear Chief Constable Cheer

I write to you in response to your letters to me dated 6 February 2014 and 23 April 2014. I am most grateful for you raising your requirements with me and giving me an opportunity to respond.

I feel it is important to restate that the footprint of air bases across England and Wales was developed and presented by ACPO and the Home Office to Chief Constables Council in October 2010¹ prior to West Yorkshire Police and West Yorkshire Police Authority agreeing to become the policing bodies that hosted the service under a Lead Force Model. The costings and service provision were agreed by the NPIA project and your force and we have endeavoured to provide the service envisaged. West Yorkshire Police are totally committed to improving and providing the service you require and we will do our utmost to work with you to achieve this.

The current service that correlates hours against revenue costs does not take account of how NPAS operates or the costs involved. In acknowledging the under use of hours in your force, I think we are now seeing the results of the NPAS model. When hours were given to forces it was on a best guess using the hours flown as a guide in the year 2010/11 and an uplift of 10% was added. The hours allocated to a force are solely for their use and do not include training, transit or maintenance flights.

NPAS ensures all such flights are as efficient as possible and we are most definitely seeing the benefits of borderless tasking and management control, which consequently ensures we are as efficient as possible.

As you know myself and ACC White have had a number of discussions on the subject of reducing hours and revenue costs and I welcome the opportunity to use your force as an example when developing a mechanism for the NPAS Strategic Board to consider correlation of operational delivery and finance.

In order to progress this further I intend organising a meeting with the North East Regional Assistant Chief Constable's and selected members of the NPAS Senior Leadership Team to explore the options available to us. I am particularly keen to involve others in the region because I have had a similar request from South Yorkshire Police to reduce their hours and there maybe a knock-on effect to others in the Region.

I trust that you will welcome this opportunity for ACC White to attend at this forum and I hope that we can work out a solution that ensures we deliver a service that supports you in the use of air assets in keeping our communities safer and feeling safe.
