<b>Title:</b> Unsuccessful Funding Applications			
<b>Executive Summary:</b> The PCC Funding Approvals meeting on 23 October 2017, considered four applications which were not supported. These are summarised as			
<p>(1) An application from a local football club to resurface a football pitch. This was declined as the cost was considered to be expensive for one pitch.</p> <p>(2) Funding to create a 'text back' service to provide support for females in the Cleveland area. This request was declined due to similar resources and Cleveland having a free, independent and confidential service in place which provides care, advice and support for victims of crime.</p> <p>(3) An application to fund support and guidance for members of the LGBT community who have experienced hate crime. This application was declined as the Victim Care and Advice Service refers LGBT victims onto specialised LGBT support services.</p> <p>(4) Funding for a project to deliver an in-reach service at Low Newton Prison (Durham), working with the women to improve support services. Post release exit plans will be developed in conjunction with the women and one-to-one support will help to facilitate a smooth transaction back into the community and reduce recidivism. This request was declined as a similar project has recently been commissioned to address the resettlement needs of women in Low Newton.</p>
