Approval to make a Voluntary Minimum Revenue Provision contribution for the financial year 2014-15

Title:

Voluntary Minimum Revenue Provision (MRP)

Executive Summary:

PCC's who have debt are required each year to set aside some of their revenues as provision for this debt. More precisely, the provision is in respect of capital expenditure financed by borrowing or credit arrangements.

In February 2014 the PCC approved the MRP Strategy (Decision 14 – 2014) to be used during the 2014-15 financial year and this has been followed. Within the MRP regulations, amendment regulation 4(1) of the 2008 Regulations revised the former regulation 28. In the new regulation 28, the detailed rules are replaced with a simple duty for an authority each year to make an amount of MRP which it considers to be "prudent".

This provides a great deal of discretion, and therefore options, to a PCC in the way in which a prudent MRP strategy is delivered. Given the current financial position and the expected continuation of funding reductions in future years there is an option for the PCC to make a Voluntary MRP contribution in 2014-15 which will then reduce the amount that the PCC needs to set aside in future years. The table below shows the potential impact:

The underspend that has developed during 2014-15 combined with the current level of General and Earmarked Reserves provides the PCC with an option to make a voluntary MRP charge in 2014-15 which will then reduce the MRP charges in future years.

Decision:

The PCC is asked to approve making a Voluntary MRP contribution within the 2014/15 financial year of £2,528k which will be funded from underspends and reserves. This will then reduce the need to set aside as much for MRP in future years.

By making a voluntary MRP contribution during 2014-15, when funding is available, this will reduce the level of MRP that needs to be set aside in future years as funding levels continue to reduce. This will then provide more resources for front line services in future years.

Once the reserves have been applied in the way that has been proposed, they cannot be utilised for other purposes. This will provide the PCC will less capacity in terms of reserves than would otherwise be the case. The PCC would still however have sufficient reserves to support the PCC's current financial plans.
