Victims Funding - My Sisters Place									
Executive Summary:									
From 1 October 2014 funding for victims of crime transferred to Police and Crime Commissioners from the Ministry of Justice (MOJ) to commission victims services. In advance of this responsibility the PCC commissioned a review of Victims Services within Cleveland. One of the recommendations within the report suggested that the PCC continues to fund the areas that were previously funded by the MOJ but for which the funding has now passed to the PCC, until 31 st March 2015.									
My Sisters Place was one of these organisations. They propose to use the £21,000 requsted from the PCC in support of an existing Independent Domestic Violence Advisor (IDVA) post (please see attached business case).

BUSINESS CASE TO CLEVELAND POLICE & CRIME COMMISSIONERS OFFICE



Re: Continuation funding for a full time Independent Domestic Violence Advisor (IDVA) to support very high risk domestic violence victims in Middlesbrough.-

Background: My Sister's Place is an independent specialist domestic violence service established in 2002, Registered Charity No: 1095827. Our core business is to provide accessible services to women 16 years of age and over, who are at risk of harm. The effects of domestic violence on families are wide ranging and we take a holistic approach to the problem, working in partnership with a range of statutory, voluntary and private sector providers and delivering a range of services in house to meet the identified needs.

This Post: Independent Domestic Violence Advisors address the safety of victims at high risk of harm from intimate partners, ex partners or family members to secure their safety and the safety of children. They are pro active in implementing plans which address immediate safety as well as longer term solutions. IDVA's are specially trained and work in the short to medium term to put victims on the path to long term safety. The role of the IDVA was established in 2005 and supports the Multi Agency Risk Assessment Conference (MARAC); Specialist Domestic Violence Court (SDVC) and more widely, Cleveland Police Vulnerable Persons Unit.

Evidence base: Research by Co-Ordinating Action against Domestic Abuse (CAADA) found that IDVA's have a significant positive impact on safety. They also found that victims are much safer when they receive intensive support and when multiple services are offered. Critically this not only refers to the safety of women but also their children.

Purpose: My Sisters Place IDVA's are part of a wider service offering a 'holistic' approach that includes a Sanctuary Scheme, Counselling, women's groups and Volunteers Scheme. We prioritise accessibility and responsivity and offer an instant access Duty system dealing with a range of problems including immediate risk issues, homelessness, immigration problems, Criminal & Family Law matters. We provide a practical problem solving approach, legal advice, counselling, educational self development groups and homeless prevention. We have 12 years of experience in this field and have built strong partnership arrangements and pathways through related services in the region.

Accreditation: The 'IDVA' service is fully accredited through Caada as a 'Leading Lights' service and in this respect complies fully with national best practice standards.

Need: National data sets show that Middlesbrough has the highest levels of domestic violence in the Country. Domestic violence accounts for over 75% of homeless applications and is an issue in 80% of Children's Safeguarding referrals. In 2013/14 financial year we received 1650 referrals and supported 949 women (active cases with a full support plan in place). These figures do not include telephone advice and other 'one off' contacts.

Request: My Sister's Place is seeking £21,000 continuation funding to support an existing IDVA post; funded to September 2014 through the Ministry of Justice. This post is costed on a full cost recovery basis.

Outputs:

- 100 Women a year will complete an initial risk assessment to inform a personal safety plan
 targeting identified risk areas to be addressed; supported emotionally and practically to
 implement their personal safety plan including signposting/referrla to a range of identified
 interventions to support the safety plan and reduce risk.
- 100 Women a year will have direct access to housing advice and support with access to secure long term housing including access to physical protection on their property through the Sanctuary Scheme - this includes outreach support for 6 months
- 50 Women a year will obtain Civil or Criminal Protective Orders and will be supported through judicial processes to enhance their safety through access to and enforcement of protective orders.
