# Procurement Report for the National Driver Offender Re-Training Scheme (NDORS)

#### 1. Purpose

1.1 Attendance on an NDORS Scheme is offered to members of the public (the Client) who would benefit from attending a driver education course, following Police intervention. The Client may be offered the opportunity to attend a course, often as a voluntary alternative to their offence being dealt with through the Criminal Justice System. The Scheme provides the Client with relevant re-training to enable them to improve their attitudes, driving skills and road awareness with the outcome of improving road safety.

#### 2. Recommendations

- 2.1 That the Police and Crime Commissioner for Cleveland and the Police Crime and Victims' Commissioner for Durham approve the Procurement process used to appoint a supplier.
- 2.2 The Police and Crime Commissioner and the Police Crime and Victims'
  Commissioner approve the procurement methods investigated and
  recommendations put forward by the Evaluation Team to award the contract to
  Bidder 2.

#### 3. Background

3.1 On 1<sup>st</sup> September 2014 a joint procurement exercise, led by Durham Police Procurement, was undertaken to identify one supplier to provide NDORS courses required for the Office of the Police & Crime Commissioner for Cleveland (OPCC) and the Office of the Durham Police Crime and Victims' Commissioner (ODPCVC) across the counties of Cleveland, Durham and the Borough of Darlington. This contract was awarded to Hartlepool Borough Council for a period of 3 years with the option to extend for a further 2 years.

- 3.2 As a result of internal reviews on service delivery and subsequently the Covid-19 Pandemic, the current contract was extended to 31<sup>st</sup> March 2021 to enable a full and competitive tender process to be carried out.
- 3.3 In advance of the advertisement of the opportunity a detailed review of the specification was conducted to ensure it was up to date and included all relevant requirements.
- 3.4 A decision was made to ensure continuity of service to award the new contract for a period of 5 years with a further 2 year extension available.
- 3.5 A decision was made to utilise an open tender via the EU Supply Tender Portal. An open tender is a competitive exercise whereby a tender is advertised and all bidders whom express an interest can access the tender documentation and submit a bid.
- 3.6 In October 2020, an advert was placed in the European Journal and the Bluelight Etendering system inviting suppliers to bid for the service. An open tender was carried out using EU Supply as the tender portal, advertising the contract in Contract Finder and OJEU as per the Public Procurement Regulations 2015.
- 3.7 Four suppliers expressed an interest in the Tender.
- 3.8 In addition to a number of mandatory pass/fail questions such as mandatory/discretionary exclusion/financial viability/ Insurance etc., the evaluation criterion was 80% Quality and Service Delivery and 20% Price. Although in the current financial climate price is a key factor, it was felt that a quality service particularly in relation to Clients re-training and road safety was procured.
- 3.9 The evaluation team, which consisted of key members from both Forces, evaluated the bid in line with the criteria set out within the Tender document as per the table below:

#### 4. Implications

#### 4.1 Finance

- 4.1.1 Based on the total cost to the Client and joint classroom based training volumes, the value of the current contract is £2,236,014.00 per annum.
- 4.1.2 The new annual contract price based on the total cost to the Client and joint classroom based training volumes is £2,208,436.00 per annum (£15,459,052.00 over the full 7 year term of the contract).
- 4.1.3 Bidder 2 is VAT exempt.
- 4.1.4 Bidder 2 submitted a bid in line with the financial envelope and the total annual bid represents a saving of £27,578.00 per annum (£193,046.00 over the full 7 year term of the contract).
- 4.1.5 The total annual central cost returned to each Force (based on classroom courses and current volumes) is: Cleveland £619,335.00, Durham £717,435.00.
