#### **REQUEST:** For PCC approval.

**Title:** Ministry of Justice National Independent Sexual Violence Advisor (ISVA) / Independent Domestic Abuse Advisor (IDVA) Fund and Domestic Abuse and Sexual Violence Support Services Fund 2022/2025 allocations

#### **Executive Summary:**

On 25 March 2022, PCC's received a letter from Minister Atkins informing them of the announcement made by the Deputy Prime Minister, that £147m of funding will be committed to over a multi-year period, until the end of 2024/25 for victim services.

This announcement responds to feedback from PCCs and the victim support sector about the challenges short-term investment causes for commissioning and delivering support. Multi-year funding will allow victim support services, and those commissioning them, to invest in building capacity and strengthen the resilience of services.

#### National ISVA/IDVA Fund

In 2021/22 the Ministry of Justice (MoJ) provided £27m to recruit and retain 700 ISVA and IDVA posts across the country. It was initially confirmed this funding would extend to 2022/23; as part of the multi-year funding update, this has now been extended to the end of 2024/25. In Cleveland, this means the 12.6 IDVA/ISVAs referred to in decision record 2021-0007071 will be funded until March 2025.

In addition to this, the government have committed to a target of 1000 ISVA/IDVA posts by 2024/25. During 2022/23 this included the recruitment and training of an additional 100 posts.

Following an expression of interest process in May 2022, Cleveland were informed they were successful in being awarded funding for two additional posts as below – again until March 2025:

Arch Teesside – ISVA - £95,697 until March 2025 My Sisters Place – IDVA - £114,923 until March 2025

#### Domestic Abuse / Sexual Violence Support Services Fund

Alongside the national ISVA/IDVA fund the MoJ opened a needs assessment process for the Domestic Abuse and Sexual Violence Support Services Fund. PCCs were required to implement an open and transparent application process from providers and submit to MoJ.

In July 2022, the MoJ confirmed that Cleveland was being awarded £297,399.49 per annum

until March 2025. This funding has been allocated as below (per annum until March 2025):

Domestic Abuse Halo - £27,000 My Sisters Place - £58,670 Harbour - £112,176

Sexual Violence Arch Teesside - £29,448 Eva - £40,000

Violence Against Women and Girls A Way Out - £30,105

#### **Decision:**

To note and approve the allocation of just over  $\pounds$ 508,019 of additional funding, covering 1 April 2022 – 31 March 2025, as set out within this decision, with  $\pounds$ 210,620 being provided to increase the number of Independent Sexual Violence Advisors within Cleveland and a further  $\pounds$ 297,399 to increase Domestic Abuse and Sexual Violence Support Services within Cleveland.
