Title: Police Property Act Funding – Justice First International Football Tournament – 17 June 2023.

Executive Summary:

Following discussion with the Police and Crime Commissioner (PCC) on 24 May 2023, it has been agreed to provide a financial contribution to a one-day multi-cultural football tournament on Saturday 17th June 2023.

The significant and underpinning aim of this event is to promote community cohesion, reduce fear of crime/fear of authorities and enhance social integration between various social and cultural groups living in Cleveland.

Based on previous events, it is anticipated that there will be 20 teams of eight players from diverse communities which in total means around 200 players and supporters. It is also hoped that Cleveland Police will actively participate in the tournament. Various service providers such as Red Cross, Cleveland Police and Health Service will be engaged with the event to raise awareness of their services and interact with various refugee and asylum-seeking groups. This is an important part of the day as it helps refugees and people seeking asylum to better understand how to access various statutory services, and enhance their confidence to do so, including report crime to the police.

The event will be evaluated through feedback forms, photographs and a short film produced by Teesside University Media Students.

Decision:

To approve a funding contribution of £1,500 to enable Justice First (Charity Registration number 1116388) to deliver a one day International Football Tournament taking place on 17 June 2023.
