**REQUEST:** For Police and Crime Commissioner (PCC) approval.

**Title:** NHS England Sexual Assault and Abuse Strategy 25-26

### Executive Summary:

This decision record form (DRF) should be read in conjunction with DRF [Ref. 2024/2025-0025](#) which outlined the decision to award NHS England Sexual Assault and Abuse Strategy 25-26 funding to **Middlesbrough Voluntary Development Agency (MVDA)** for the development, facilitation and coordination of activities which would support improvements across all partners responding to sexual harms and increase victim experience and confidence for a 12 month period.

Since completion of the above DRF, further communication from NHS England confirmed that an additional 6 months of funding would be awarded to extend this role, taking delivery to 30 September 2026.

The OPCC therefore agrees to provide additional grant funding to **Middlesbrough Voluntary Development Agency (MVDA)** to the value of £30,918 increasing the total funding awarded to £90,822.40 for the delivery period 1 April 2025 – 30 September 2026. The OPCC will retain a management charge of £4,541.18 for the same 18 month period to support OPCC activities related to the management of the arrangement.

This decision was discussed with PCC Matt Storey on 23 April 2025 and has his full agreement.
